Kuwait Integrated Petroleum Industries Company (KIPIC) was established on 18th October 2016 as a new Subsidiary to Kuwait Petroleum Corporation (KPC). After months of careful and meticulous planning ensuring that the company is built on strong foundations and assembling a high caliber team from the Kuwaiti Oil Sector, KIPIC went live on 1st of May 2017.



OUR MISSION

To operate an integrated complex that manufactures refined petroleum and petrochemical products and supplies Liquefied Natural Gas (LNG) after regasification in a reliable, efficient, safe and environmentally responsible manner while maximising profit, developing a professional and competent workforce and enabling Kuwaiti private sector's participation in the downstream petroleum industry.

OUR VISION

To be a leader in integrated refining, LNG and petrochemical operations that maximises shareholder value, achieves operational excellence, commits to the development of our people and contributes to the development of the local economy.

KIPIC is responsible for operating and managing the largest grassroots integrated complex for refining, liquefied natural gas import facilities, and petrochemicals manufacture businesses at Al-Zour complex. The three facilities are currently under construction and anticipated to be operational between 2019 and 2023.

OUR PROJECTS

AL ZOUR REFINERY

Al-Zour Refinery facility will process 615,000 Barrel per day of Kuwait Crudes to produce high value products and low sulphur fuel oil required by Ministry of Electricity and Water (MEW). Al Zour Refinery is currently in the engineering, procurement and construction phase. Commencement of operations in a phased manner is expected by 2019.

LIQUEFIED NATURAL GAS IMPORT (LNGI)

The Liquefied Natural Gas Import (LNGI) facility will be responsible for importing and vaporizing natural gas up to 3,000 BBTU of liquefied natural gas per day. Currently, the project is in the engineering, procurement and construction phase and this terminal is expected to be completed and commissioned in two phases starting from 2020 and fully operational by 2021.

PETROCHEMICALS FACILITY

The Petrochemical Facility will manufacture base petrochemical products with an annual capacity of 2,761 KTPA of aromatics and Poly-Propylene. The Facility is in the front-end engineering design phase with an expected completion date of 2019. The engineering, procurement and construction phase is planned to be completed in 2023, and commissioned thereafter.



OUR COMMITMENT TO KUWAIT


