KPC has appointed M/s Shell to work on the feasibility study to improve the cost of CO2 recovery for meeting the above objective. Currently this project is ongoing and further availability of CO2 from ZOR will be dependent on the outcomes of this study. KPC is in the process of identifying additional fields in Kuwait which could potentially be used for EOR using PRIZe CO2 sources. It may be worthwhile to strategic direction with regard to utilisation of captured CO2.</p>
